

## **RSA DOMUS AUREA di CASTELFORTE**

ENGLISH The "Domus Aurea" nursing home is located in Castelforte, a municipality on the south-eastern border of the Province of Latina, at the foot of the Aurunci Mountains Massif, near Minturno, Formia and Gaeta. The property is located in a green park surrounded by centuries-old trees, near the historic center and the hamlet of Suio, a spa town of ancient origin.

The "Domus Aurea" RSA is a Health and Social Health Facility that provides Extra-Residential Territorial Assistance – Residential Hospital services to Non-Self-sufficient People, including the Elderly.

FRENCH La maison de retraite « Domus Aurea » est située à Castelforte, une municipalité à la frontière sud-est de la province de Latina, au pied du massif des montagnes Aurunci, près de Minturno, Formia et Gaeta. La propriété est située dans un parc verdoyant entouré d'arbres centenaires, à proximité du centre historique et du hameau de Suio, une ville thermale d'origine ancienne.

La RSA « Domus Aurea » est un établissement de santé et de santé sociale qui fournit des services d'Assistance Territoriale Extra-Résidentielle – Services Hospitaliers Résidentiels aux personnes non autonomes, y compris les personnes âgées.

GERMAN Das Pflegeheim "Domus Aurea" befindet sich in Castelforte, einer Gemeinde an der südöstlichen Grenze der Provinz Latina, am Fuße des Aurunci-Massivs, in der Nähe von Minturno, Formia und Gaeta. Die "Domus Aurea" RSA ist eine Gesundheits- und Sozialgesundheits Einrichtung, die außerstationäre territoriale Hilfe – stationäre Krankenhausdienste für nicht autarke Menschen, einschließlich älterer Menschen, anbietet.

Accredited with DCA n. U00008 of 12 January 2015 with the NHS of the Lazio Region, the "Domus Aurea" RSA is a High Level Assistance collective residence whose Residential Regime can accommodate up to 60 residence places divided into 3 nuclei of 20 p.r. each:

- **Love Module: Senescence Area** (partial or total limitation of self-sufficiency), with particular regard to people suffering from chronic diseases;
- **Bread Module: Area of Motor Disability** (conditions of considerable dependence), referring to people with functional disabilities;
- **Fantasy Module: Area of Mental Distress**, referring to people with mental disorders.

The request for access to the "Domus Aurea" RSA can be made by the Guest, by his/her family member, by the general practitioner and by other local services, in compliance with the person's will, in the event of incapacity to understand or will on the part of the person who assumes responsibility.

For admission to the Facility, the application must be submitted to the C.A.D. (Home Care Center) of the health district of the ASL to which they belong, it will be the responsibility of the competent offices to organize a visit, in order to subject the interested party to a Multidisciplinary Assessment from which the degree of non-self-sufficiency that determines the level of care emerges.

If the Evaluation Unit of the C.A.D. shows a degree of assistance compatible with inclusion in the RSA, a special Nulla Osta will be issued and the interested party will be able to access the RSA of his choice. If there is no availability of places, the Guest will be placed on a Waiting List.

## **SERVICES OFFERED**

**Medical assistance** guaranteed by the presence of the Responsible Doctor (MR) and General Practitioners (GPs), who, among other things, carry out the following services: General Medicine Visit and/or Check-up; Prescription of drugs; Rehabilitation activities in accordance with the figure of the Physiotherapist; Personalized diets in accordance with the figure of the Dietitian; Request for specialist visits; Proposals for hospitalization. General practitioners are present according to the ASL regulations or at the need of the Guest. Medical assistance is also guaranteed during the night, on holidays or for urgent situations through the Medical Guard and the availability of the attending physicians.

**Nursing Services** guaranteed 24 hours a day, every day of the year, including, in addition to the normal Routine Services (administration of drugs following a medical prescription, medications,...): the Control of Therapeutic Services, the Prevention of Infections and Falls; early identification of any changes in physical health and functional impairment; the timely activation of the necessary interventions by the other competent operators.

**Rehabilitation services** aimed at preventing the involutionary effects of stabilized damage, with particular regard to the re-education of the Guest to carry out common daily activities as well as psychosocial

rehabilitation, also through Occupational Therapy. The rehabilitation activity is ensured through the presence of Physiotherapists who perform, among other things, the following services: Passive mobilization to limit the damage related to immobility; Active gymnastics (when the Guest is able to perform movements without the aid of the operator) and passive gymnastics (when the Guest needs the help of the operator to perform certain movements). This activity is provided both in the gym and in the patient rooms, moreover, within the RSA, there is an environment intended for Physiokinesitherapy.

**Diabetes Advice and Control** including both general and specific interventions on the diets of individual Guests, provided by a Dietitian present at the residence. The "Domus Aurea" nursing home offers a choice in the personalized menu and adapts the schedules to the physiological rhythms of the person. In addition, specific menus are provided based on the needs (e.g. diabetics) and beliefs of the Guest (e.g. Buddhist, vegetarian).

**Psychological Support Services** and participation in the verification of the implementation of the individual therapeutic project, provided by the Psychologist with the active participation of the entire health and social-welfare team and voluntary associations.

**Personal Help and Assistance** services consisting of helping the Guest for the hygiene and care of their person and the environment, provided by Nurses and Social and Health Workers.

**Activities of Animation**, Occupational Therapy, Recreational, Integration and Connection with the family and social environment of origin, especially through recreational activities, psychological techniques of orientation and reactivation for subjects with mental deterioration, including senile, systematic meetings with family and friends. The activities are guaranteed by Professional Educators who have the task of involving Guests in entertainment activities also aimed at the attempt at overall psycho-physical recovery. There are various entertainment activities.

**Social Assistance Service** responsible for maintaining relations with Guests, family members, social services, ASL and specifically the CAD. It provides for the handling of administrative and bureaucratic procedures on behalf of the Guests, as well as social secretarial techniques.

Hotel-type services including accommodation, food and general services.

## **RATES**

The costs of staying in the facility are 50% borne by the SSR and 50% by the Guest. If the Guest does not have sufficient income to ensure the fulfilment of the obligation to pay, in whole or in part, the required fee, he is required to request a contribution from the Municipal Administration of Residence. This contribution is determined annually with the calculation of the ISEE on the income declared with the annual tax return.

## **QUALITY**

In order to guarantee a service that is always oriented to the needs of the Users, in the interest of the Guests and in compliance with the regulations in force, the Company has introduced a Quality System inspired by the principles of the international standard UNI EN ISO 9001: 2008 continuously updated with Internal Procedures, Protocols and Guidelines.
